

SUMMARY ANNUAL REPORT FOR BANNER HEALTH EMPLOYEES 403(B) PLAN

This is a summary of the annual report for the Banner Health Employees 403(b) Plan (Employer Identification Number 45-0233470, Plan Number 044) for the plan year January 1, 2022 through December 31, 2022. The annual report has been filed with the Employee Benefits Security Administration, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

Benefits under the plan are provided by a trust fund. Plan expenses were \$19,077,214. These expenses included \$361,631 in administrative expenses and \$18,673,632 in benefits paid to participants and beneficiaries, and \$41,951 in certain deemed and/or corrective distributions. A total of 12,357 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$145,966,125 as of the end of the plan year, compared to \$195,067,441 as of the beginning of the plan year. During the plan year the plan experienced a change in its net assets of -\$49,101,316. This change includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. The plan had total income of -\$30,024,102, including employee contributions of \$2,155,313, rollover contributions of \$683,024, and earnings from investments of -\$32,862,439.
