Here are answers to questions you may have about the key features, benefits, and rules of your plan.

When can I enroll in the Plan?

There is no waiting period. You can enroll in the Plan at any time.

How do I enroll in the Plan?

Enroll online at any time, or by calling the Fidelity Retirement Benefits Line at 1-800-343-0860.

When is my enrollment effective?

Your enrollment becomes effective once you elect a deferral percentage, which initiates deduction of your contributions from your pay. These salary deductions will generally begin with your next pay period after we receive your enrollment information, or as soon as administratively possible.

How much can I contribute?

Eligible faculty and classified staff who contribute at least \$10 each pay period to the VCU 403(b) Tax-Deferred Annuity Plan will receive matching contributions from VCU to their Cash Match accounts.

What is the IRS contribution limit?

The IRS contribution limit for 2025 is \$23,500.

Does the organization contribute to my account?

Eligible faculty and classified staff who contribute at least \$10 each pay period to the VCU 403(b) Tax-Deferred Annuity Plan will receive matching contributions from VCU to their Cash Match accounts.

When am I vested?

You are immediately 100% vested in your own contributions to the VCU Cash Match Plan, as well as in any of the Organization's matching contributions and any earnings on them.

What are my investment options?

To help you meet your investment goals, the Plan offers you a range of options. You can select a mix of investment options that best suits your goals, time horizon, and risk tolerance. The many investment options available through the Plan include conservative, moderately conservative, and aggressive funds. A complete description of the Plan's investment options and their performance, as well as planning tools to help you choose an appropriate mix, are available online.

What if I don't make an investment election?

We encourage you to take an active role in the VCU Cash Match Plan and choose investment options that best suit your goals, time horizon, and risk tolerance. If you do not select specific investment options in the Plan, your contributions will be invested in the Fidelity Freedom® Fund - Class K6 with the target retirement date closest to the year you might retire, based on your current age and assuming a retirement age of 65, at the direction of VCU.

If no date of birth or an invalid date of birth is on file at Fidelity, your contributions may be invested in the Fidelity Freedom® Income Fund Class K6. More information about the Fidelity Freedom® Fund - Class K6 options can be found online.
