
SUMMARY ANNUAL REPORT FOR THE DISNEY SAVINGS AND INVESTMENT PLAN

This is a summary of the annual report for the Disney Savings and Investment Plan (the "Plan"), E.I.N. 95-4545390, Plan number 011, for January 1, 2019 to December 31, 2019. The Plan annual report has been filed with the Employee Benefits Security Administration as required under the Employee Retirement Income Security Act of 1974 (ERISA).

BASIC FINANCIAL STATEMENT

Benefits under the Plan are provided by a Trust. Plan expenses were \$467,960,620. These expenses included \$467,525,560 for benefit payments to participants and beneficiaries of the Plan, \$49,182 for corrective distributions, \$127,495 in certain deemed distributions of participant loans, and \$258,383 in administrative expenses. A total of 62,367 persons were participants in or beneficiaries of the Plan at the end of the plan year.

The value of Plan assets, after subtracting liabilities of the Plan, was \$8,629,125,635 as of December 31, 2019, compared to \$6,781,183,141 as of December 31, 2018. During the plan year the Plan experienced an increase in its net assets of \$1,847,942,494. The decrease included unrealized appreciation and depreciation in the value of Plan assets; that is, the difference between the value of the Plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The Plan had total income of \$2,256,896,974 that included a gain from investments of \$1,795,325,958, employer contributions of \$80,254,369, employee contributions of \$341,034,607, rollovers of \$36,612,265, and participant loan interest of \$3,669,775.
